CREATING THE FIVE (5) SECTORAL COMMITTEES AND TECHNICAL WORKING GROUP (TWG) OF THE LOCAL DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF MATNOG, SORSOGON, DESIGNATING THE COMPOSITION OF EACH COMMITTEE AND DEFINING ITS FUNCTIONS

WHEREAS, LDC Resolution No. 3 s. 2019 provides for the creation of five (5) sectoral committees and Technical Working Group of the Local Development Council (LDC), namely, social, economic, physical/land/use/infrastructure, institutional and environmental.

WHEREAS, DILG MC No. 2007-114 provides for the guidelines in updating the medium-term Comprehensive Development Plan (CDP), contents of the Executive Legislative Agenda (ELA), formulation of the Provincial Development and Physical Framework Plan (PDPFP) and reconstitution of the Local Development Council as the mandated planning structures:

NOW THEREFORE, I, CATTLEYA M. SO, Municipal Mayor of the Municipality of Matnog, Sorsogon, by virtue of the powers vested in me by law, do hereby designate the composition of the Five (5) Sectoral Committees and Technical Working Group and its functions:

#### Section 2. FUNCTIONS.

Assist the LDC in the performance of its functions;

b. Provide the LDC with data and information essential to the formulation of plans, programs and activities;

Define sectoral or functional objectives, set targets and identify programs, projects and activities;

d. Collate and analyze data and conduct studies;

e. Conduct public hearings on sectoral planning, projects and activities;

f. Monitor and evaluate programs and projects;

g. Regularly update sectoral database; and

h. Perform functions assigned by the LDC

Section 3. SUPPORT REQUIREMENTS. The Secretariat of the LDC shall call upon the members of the five sectoral committees in the local government unit through their respective department heads for a meeting and assistance of relevant data or information necessary in the formulation of the Comprehensive Development Plan and in the implementation of various activities essential for the completion of the plan.

Section 4. Effectivity. The five sectoral Committees and Technical Working Group shall exercise their functions immediately and until the Comprehensive Development Plan has been formulated and adopted by the concerned Sanggunian.
