RE-ORGANIZATION OF THE MUNICIPAL NUTRITION COUNCIL, OF MATN OG, SOR SOGON AS THE IMPLEMENTING ENTITY IN THE NATIONAL NUTRITION PROGRAM OF THE GOVERNMENT.

Whereas, it is imperative to re-organize the composition and membership of the Municipal Nutrition Council to empower the facilitation of an efficient and effective nutrition projects especially at the barangay level;

Whereas, through this council the local nutrition programs could be properly centralized to achieve sustainable nutrition awareness and responsiveness from the people of Matnog in coordination with the LGU for the development of better nutrition;

NOW, THEREFORE, I CATTLEYA M. SO, Municipal Mayor of Matnog, Sorsogon, by virtue of the power vested in me by law, hereby re-organized the Local Nutrition Council, viz;

Section 2. Funding Support

The Municipal Government shall see to it that adequate fund be appropriated to shoulder nutrition expenses & other related purpose.

Section 3. Capability, Man Power Support & Term Office

3.1 **The Matnog Municipal Nutrition Council** through its Municipal Acton Officer shall pursue innovations and excellent strategies that will make the impact to the conceived nutrition program for the constituents of Matnog;

3.2 **The Matnog Municipal Nutrition Council** through its Municipal Action Officer shall initiate useful programs that will enhance nutrition awareness among the constituents in order to ensure better quality of life in the Municipality of Matnog ; and

3.3 To sustain the above commitments for a health conscious Matnog, each member of the council is enjoined to furnish the council with a written reason/notice of their failure to attend any of the Matnog Municipal Nutrition Council's Meeting they may not be able to attend to; and

3.4 **The Matnog Municipal Nutrition Council** is empowered to replaced the service of any its member who based on attendance records with no apparent reason/s had incurred three consecutive absences from the meeting called for by the council and based on the performance of duty is unresponsive to the nutrition problems of the community.

Section 4. Secretariat Services

The Council shall among themselves create a secretariat with the Municipal Nutrition Action Officer as the head with two other members to call for a meeting as the need arises.

Section 5. Any previous Municipal circulars or executive orders on similar subject or instruction in consistent hereto hereby repealed and/or modified accordingly.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately and shall remain enforced until otherwise revoked.
